The Graduate School, Chiang Mai University would like to announce that the following candidates have passed the admission process and are eligible to enroll international programs for the 2nd semester of the academic year 2019 (starting from December 2019) (2 persons) attached list.

Formal Registration and Course Enrollment:

The above candidates must fill out the student's record starting from 28th January 2020 at the website <http://www3.reg.cmu.ac.th/stdinfo/graduate/> and report in person to the Registration Office, Chiang Mai University on **29th January 2020, during 8.30–11.30 hr.** Candidates who fail to do so will be considered to have waived these offers of admission. A person who has been accepted as a student by Chiang Mai University must enroll him/herself as a student and must pay academic fees in accordance with the related regulations of Chiang Mai University. By doing so, the student enrollment will be counted as complete as date and time stated

In case which a student is accepted in more than 1 Major, the student can enroll in those Majors **but they must be Regular Session and Special Session. The enrollment in Regular Session and Regular Session or Special Session and Special Session is not possible.**

How to dress for student photo on the Student Enrollment Day

For Graduate Studies: Please dress appropriately; wear plain white button-up shirt (a suit is allowed); no accessories nor eyeglasses.

- Female student: hair must not cover the eyes; long hair must be sprucely tied up
- Male student: hair must be sprucely trimmed and not cover the eyes; no beard or mustache

Required Documents for Registration:

The Accepted Students must bring all of the relevant evidence for the Enrollment designated by the University to the department in charge of the Student Enrollment on the scheduled date and time. If the evidence is not complete, the University will not accept the Enrollment of the student; except for student who expects to graduate in 1st semester, academic year 2019 and will be completely graduating from the current Institution/Major before the first day of class in 1st semester, which the student will enter in accordance with Chiang Mai University's Academic Schedule (16th December 2019). And will be allowed to submit the graduation evidence within 15 days, starting from the first day of class.

1. Graduated Student must submit the complete version of Transcript (stating the date of graduation) of Bachelor's Degree or Master's Degree certificated by the Academic Institute where student graduates from (the original Transcript and 2 copies are needed)
2. For student who graduates in 1st semester, Academic year 2019: submit the most recent version of Transcript of Bachelor's Degree or Master's Degree certificated by the Academic Institute where student graduates from, along with the Transcript Submission Leniency Document (the original Transcript and 2 copies are needed)

Note: For foreign students: the Transcript must be the English version only

3. ID Card (Original)
4. One copy of House Registration (For Thai students)
5. One copy of Passport (For foreign students) and the page with "Non-Immigrant Visa" stamp

In case which student cannot come for the Student Enrollment on the designated date and time, Faculty/Major must inform the Registration Office directly to ask for permission to let student enroll afterwards as a special case.

6. One Medical Certificate (Original) from medical institution e.g. public hospital, private hospital or clinic

Note: When student has already enrolled him/herself and paid academic fees, IT account will be given to student. Student will be able to access the internet and Library Service. But for Health Service; it will be available after student has finished with the registration.

Evidence required for the making of Student ID Card

1. Two copies of ID Card or Civil Servant Card, along with House Registration or Passport (For foreign students)

Note: * Student ID can be checked on the Student Enrollment Day or in the website <http://www3.reg.cmu.ac.th/stdinfo/graduate/>

* For any copies of documents: must be A4 and signed for approval in every paper

Registration and Tuition Fee Payment:

Accepted student must pay academic fees (in packaged-type) on the Student Enrollment Day (one semester). For details of academic fees; please visit <http://www.grad.cmu.ac.th/documents/1000000893-1.pdf> (Fee of Student Enrollment is already included). Payment Availability:

- Cash
- Cashier's Cheque pay to the order of "Chiang Mai University"
- Credit Card (1% fee)
- Debit Card (no fee) (If the amount is more than 20,000 Baht
Please extend the daily limit before paying)

Once paid, the academic fee cannot be refunded.

**** For student who is a Scholarship Grantee (Government Scholarship): Student needs to integrate with own Major/Faculty (1 week before the Student Enrollment Day) to ask for Permission Paper to be lenient on academic fees payment on the Student Enrollment Day, then submits it to Registration Office****
